**GRENADA**

**ACT NO.        OF 2025**

**AN ACT** to provide for the Titles and Styles of the Sovereign, the Heir to the Throne, the Governor-General and the Governor-General's spouse and related matters.

**BE IT ENACTED** by the King's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives and by the authority of the same as follows—

**Part I**

**Preliminary**

**1. Short title and commencement**

This Act may be cited as the

ROYAL AND VICEREGAL TITLES ACT, 2025

and shall come into effect by a day to be fixed by the Governor-General by Notice published in the Gazette.

**2. Interpretation**

(1) In this Act—

“Governor-General” means the Governor-General of Grenada;

“Heir to the Throne” means the person next in the line of succession under the terms of the Succession to the Crown Act, 2013, the Act of Settlement, 1701 and the Bill of Rights, 1689 of the Parliament of the United Kingdom.

**PART II**

**Royal Titles and Styles**

**3. Royal Title and Style**

The royal style and titles of His Majesty, for use in relation to Grenada and all matters for whose foreign relations His Majesty's Government in Grenada is responsible, shall be—

Charles the Third, By the Grace of God, King of Grenada and of His other Realms and Territories, Head of the Commonwealth.

#### **4. Title and Style of Heir**

- (1) The royal style and title of the Heir to the Throne, for use in relation to Grenada, shall be—  
Prince of Carriacou, if male; or  
Princess of Carriacou, if female.
- (2) The wife of the Prince of Carriacou shall be entitled to the title of Princess of Carriacou.

### **PART III**

#### **Viceregal Titles and Styles**

#### **5. Title of Governor-General**

- (1) The title and style of the Governor-General shall be—  
Governor-General of Grenada, with the style and dignity of His or Her Excellency.
- (2) The Governor-General shall additionally be entitled to use any other such titles or honours as conferred upon them by His Majesty.
- (3) A Governor-General, upon leaving office, shall be entitled to the style and dignity of The Right Honourable for the rest of their life.

#### **6. Title of Governor-General's Spouse**

- (1) The title of the wife of the Governor-General shall be—  
Vicereine of Grenada, with the style and dignity of Her Excellency.
- (2) The title of the husband of the Governor-General shall be—  
Viceregal Consort of Grenada, with the style and dignity of His Excellency.
- (3) The spouse of the Governor-General, upon the Governor-General leaving office, shall be entitled to the style and dignity of The Right Honourable for the rest of their life.

#### **7. Spouse's position in order of precedence**

The spouse of the Governor-General shall rank immediately behind the Governor-General in the order of precedence.
